SECTION 179 DEDUCTION

Allows you to deduct the cost of qualifying equipment up to \$1,160,000, rather than depreciating the cost over a period of several years. The maximum dollar amount of equipment you can purchase in any calendar year is \$2,890,000 before the deduction is reduced dollar for dollar.

EXPERT RESOURCES

A 80% bonus depreciation can be taken on new and used equipment purchases, in addition to the Section 179 deduction.

For any remaining amount above the \$1,160,000 allowance, you are entitled to take a 80% Bonus Depreciation. The maximum dollar amount of equipment you can purchase in 2023 is \$2,890,000 before the deduction is reduced dollar for dollar.
